Discussion:

In determining the costs of proposed practices, will need to have data to inform what the costs will be for all stakeholders, e.g. university faculty, district teachers, candidates

Rebecca Watts will seek Governing Board approval if the Work Group feels additional members are needed to complete the work.

There is the sense that stakeholders throughout the state are not aware of changes that have occurred in the Elementary Education Program in the last few years, e.g. admissions selectivity.

There is concern for the Work Group's ability to identify meaningful metrics to inform the work to achieve pre-eminence in educator preparation. There is concern that reputation of programs often is founded in a particular aspect of a program, e.g., educational leadership, research, urban focux in educator preparation. Wyoming statute does not allow student growth to be attributed to an individual teacher. Student growth data are only available at the school/building level. This constrains the TEI ability to do comparisons between students taught by UW graduates and students taught by graduates of other universities

David Yanoski from Marzano identified comparitor peer institutions for preliminary comparitor research in Title II data: University of Northern Colorado, Colorado State University, Utah State University, Chadron State University, Black Hills State University, University of Nebraska Kearney, idaho State, BYU Idaho, Weber State University, Valley City State University. There was discussion about adding Emporia State University. Rebecca Watts

suggested consideration of including Miami University in Oxford, Ohio as a comparitor peer program serving a largely rural population. Pete Moran suggested adding the University of Northern Iowa to the comparitor list as a strong institution with a rural focus

Pete Moran led a discussion on the historic challenges with the College of Education placing student teachers in the optimal places for student teachers and for school districts. Several years ago there was a decision in the College to constrict the number of districts in which student teachers are placed throughout the state. This decision has caused difficulty for student teachers including cost issues. Candidates who have family members in a community would be able to do a student teaching placement in that community and reduce the candidates costs for completing the student teaching internship. Further the constriction of placements has resulted in some school districts have great difficulty in recruiting teachers to serve in their district.
