Discussion:

Discussion around the goals of the Trustees Education Initiative and concern regarding establishing specific goals and demonstrating achievement of those goals in a valid and reliable evidence base. Concerns were raised regarding attempting to gather further qualitative evidence from Wyoming LEA leaders and teachers. Some members felt that it would be more effective to move directly to a process of identifying exemplar programs for evaluation and site visits.

Discussion of data on perceptions of Wyoming stakeholders to date; there is a need for a qualitative analysis of current perceptions.

Question if TEI needs IRB approval to engage the stakeholders in all the work groups. Suzanne Young advises that there is no need for IRB approval for the work of TEI. If results were to be published
