

#### **Overview**

- In January 2010, the Board approved a two-year program of fees for FY 2011 and FY 2012 coinciding with biennial budget requests and tuition decisions.
- Certain expenditure increases from the 2010 legislative session were not known when mandatory rates (including room and board) were approved.
- For Section II budget units to cover these costs will require expenditure reductions, use of one-time reserves, and rate adjustments.
- Section II grants (non-fee related) will need to be adjusted.
- As with tuition increases, ARRA funds covered fee increases in FY 2011, so students will notice an increase on their bills in FY 2012.



## Total Section II Impacts of Employershare of Increased Benefits Costs

### **Mandatory Fees**

- Mandatory fees are paid by all Laramie campus full-time and part-time students.
- Six mandatory fees support Student Union, Student Services\*, Student Health Service, Intercollegiate Athletics, Campus Recreation Programs, and Transit.
- \* Student Services fee supports ASUW, Student Media, Recycling, Wellness, AWARE, Music/Theatre, and Student Leadership and Civic Engagement.



### **Applicability to FY 2012 Fees**

- There are selective impacts to mandatory fees from the increase in the retirement contribution and group health insurance costs because:
  - Section II mandatory fees supporting salary and benefits for employees are limited to certain budget entities
  - Extent to which Section II budget entities already assumed an increase in group health insurance costs for FY 2012. (Some entities included group health insurance increases of 7% in their planning for FY 2012.)

## Mandatory Fee Increases for Part-Time Students and Summer School

- Mandatory fee increases for part-time students are based on the underlying full-time student fees [increases only apply to Wyoming Union (\$4.88), Student Services (\$1.78) and Transit (\$.56), (annual basis)].
  - Per credit hour for 1-3 credits: Wyoming Union (\$.60) and Student Services (\$.26), (annual basis).
  - Fixed rate for Transit (\$.56), (annual basis).
- Summer 2012 mandatory student fees for Student Health Center and Wyoming Union would also change in this proposal.
  - Student Health Services increase of \$2.54
  - Wyoming Union increase of \$0.30



### **Non-Mandatory Fees**

- Housing and Dining Services (depends on particular plan selected)
  - Room- 0.7% to 1.0% increase
  - Board- about 0.5% increase
  - Rent- 0.2% increase
- Other non-mandatory fees include charges for technology fees for voice services, transit and parking fees, bicycle locker rental fees, day-care fees, fleet services rentals, WyoOne ID cards, trademark licensing, and visiting scholar fees. The majority of these fees are charged to non-students.
- All mandatory and non-mandatory fees are listed in the <u>University</u> of <u>Wyoming Fee Book</u> publication.
