

State/Federal Context

- The State of Wyoming and the University of Wyoming use a biennial (two-year) budget process
- State of Wyoming has sustained a strong fiscal position (strong budget reserves and revenue surpluses); other states are beginning to see improved revenue picture
- Federal funding issues are not insignificant




Tuition and Fees and Budget Planning

- UW moved to two-year approach to tuition and fee setting; enhances financial planning for University and students and families; coincides with biennial budget planning of State
- UW is ranked 150th (out of 150) in the nation among public, doctoral institutions for tuition and fees.
- Other states characterized by low tuition and high state support have increased tuition more rapidly than UW in the last few years
- Comprehensive recommendation for tuition and fees will be brought to the Board in Fall 2011 for the 2013-2014 biennium

067 Operating Budget Request

- Salary increase —link UW request to State Strategy (every 1% costs \$1.6 million for Section I employees)
- General Fund appropriation for School of Energy Resources operations at \$10 million per year
- Libraries final \$1.8 million per year of supplemental request for GWLA membership
- Technology for teaching and research:
 - Instructional technology \$1.3 million per year
 - High performance computing initiative \$1.1 million per year
 - Information technology infrastructure \$2.17 million, non-recurring
- State matching fund request: facilities and endowment \$50 M total (non-recurring)
 - Large list of items under consideration
 - Potential facilities match (\$20 M), endowment match (\$20 M), and athletics (\$10 M)
- New facilities operations and maintenance \$1 million per year
- Brucellosis consortium to maintain level funding \$200K per year



Other Budget Request Items

Medical Education

- Salary increase (cost of \$110 thousand for every 1% increase)
- Follow-up to B11 to realign budget for UW Cheyenne (from personnel to support and contractual)
- Request for clinic income authorization and 32 permanent positions for UW Casper no General Fund request; B11 already approved but needs reapproved for next biennium
- Expansion costs (potentially \$1 M per year), UW support costs (\$40K per year) and summer tuition bills (\$200K per year) for WWAMI program
