Call to Order

Trustee President Dave True called the meeting to order at 6:03 a.m.

Roll Call

Ex-officio members participating: Governor Mark Gordon, Superintendent for Public Instruction Jillian Balow, ASUW President Jason Wilkins, and Executive Director of the Wyoming Community College Commission Sandy Caldwell were in attendance. Ex-officio trustee UW President Laurie Nichols was not in attendance.

General Counsel Tara Evans, Managing Director and Deputy Secretary Shannon Polk, and Desktop Support Team Supervisor Lisa Stafford were in attendance for the meeting.

Public Session #1

Trustee Brown moved that the UW Board of Trustees enter into Executive Session for the purpose of consideration of the appointment of a public employee under Wyoming Statute 16-4-405(a)(ii), and designated that the executive session would be attended by the 12 voting members of the Trustees, ex-officio members Superintendent for Public Instruction Jillian Balow, ASUW President Jason Wilkins, Governor Mark Gordon, Executive Director of the Wyoming Community College Commission Sandy Caldwell, Managing Director Shannon Polk, Desktop Support Team Supervisor Lisa Stafford, and General Counsel Tara Evans. Trustee Marsh seconded the motion, which passed with a unanimous vote at 6:07 a.m.

The Board adjourned Executive Session and entered back into public session at 6:22 a.m.

Public Session #2

Trustee True provided background information regarding the trustee ad hoc committee assigned to the acting president process. Per Section 5-2 of the Bylaws of the Trustees, President True appointed an ad hoc committee of the Trustees to develop recommendations on a process and timeline for appointment of the acting president.

Acting President Working Group Recommendation

Trustee Moore discussed the details of the process moving forward.
