Dr. Kevin Carman received a B.A. (1982) in Biology from McPherson College, graduating Magna Cum Laude; an M.S. in Biological Oceanography (1984) from Florida State University, and a Ph.D. (1989) in Biological Oceanography from Florida State University. Dr. Carman served for the past 7+ years as the Executive Vice President & Provost of the University of Nevada, Reno where he also holds the rank of Professor in the Department of Biology. Prior to that, he served 7 years as the Dean of the College of Science at Louisiana State University. Dr. Carman has held multiple academic appointments at Louisiana State University, progressing from a postdoctoral researcher to a full Professor in the Department of Biological Sciences. Academic Affairs is recommending Dr. Carman be hired with tenure at the rank of Professor. He will also serve as the Provost and Senior Vice President of Academic Affairs.

Peter Parolin became Dean of the College of Honors in 2019; he is also Associate Professor and past Department Head of English. He earned his B.A. from University of British Columbia, and his MA and Ph.D. from the University of Pennsylvania. He is the co-editor (with Pamela Allen Brown) of *Women Players in England, 1500-1660: Beyond the All-Male Stage* (Ashgate, 2005), as well as many articles on Shakespeare and performance history. He has also received multiple teaching awards, including the Beatrice Gallatin Beuf Golden Apple Award for Teaching Excellence in Freshman Level Courses and seven Arts and Sciences Top Ten Teacher Awards. In addition to teaching and writing, Parolin regularly appears in local and university stage productions. For English his classes range from

Introduction to English Studies through Shakespeare to Performing War. For Honors, he teaches First-year Colloquium and Shakespeare in England and Italy.

Bill Mai is a graduate of the University of Wyoming with a B.S. in Range and Wildlife Management (1987) and MBA with an emphasis in economics (1989). He has spent his career in a variety of leadership positions with the State of Wyoming and the University of Wyoming. Since November of 2020 Bill has been serving in the Acting Vice President for Governmental Relations role. At UW he has served as the Deputy Vice President for Operations the Acting Vice President for Operations and the VP for Finance and Administration and CFO. He has also served with the state as the Chief Economic Advisor and Legislative Liaison for the Wyoming Governor's Office as well as a legislative analyst, senior legislative analyst, and manager of the Budget/Fiscal Division of the Legislative Services Office and administrator of the Economic Analysis Division of the Wyoming Department of Administration and Information. In these roles, he has served as co-chairman of the Consensus Revenue Estimating Group (CREG), the team charged with forecasting Wyoming's bi-annual revenue and earnings to the Wyoming General Fund and as lead staff to the Wyoming Legislature's powerful Joint Appropriations Committee. In these roles, he has helped guide the funding decisions related to operational and capital requests from the University of Wyoming, the community colleges, and economic development agencies in the State.
