He has received an Outstanding Educator Award from the COANR and Gamma Sigma Delta Award of Merit (UW Chapter). Christianson, David Associate Professor

David Christianson (Ph.D.) joined the Department of Ecosystem Science and Management in 2019. His research successes include securing a single grant of \$482,281 as PI in external funding for research in large herbivores in his early academic career. This jump-start to his research allowed him to develop additional collaborations with sponsors leading to a total of \$2.67 million in external funding as PI or Co-PI in the last 7 years. He continues to broaden his research program to address applied questions on wildlands while complimenting his interest in fundamental ecological inquiry into consumer functioning. This line of inquiry has produced 34 peer-reviewed publications, many in top-tier science and ecology journals and his impact continues to remain strong as he consistently publishes 2-3 journal articles every year. Complimentary lines of inquiry into climate change, statistical methods, and ecosystem dynamics have allowed him to secure additional funding for a comprehensive research program involving 36 undergraduate students, 9 graduate students (3 Ph.D., 6 Masters, 3 of whom have finished), 2 post-docs, and several staff who are successfully publishing our research. He has started 3 graduate students (1 PhD, 2 Masters) since arriving at the University of Wyoming.

van Diepen, Linda Associate Professor

Linda van Diepen (Ph.D.) joined the Soils group in the Department of Ecosystem Science and Management in the Fall of 2015. Since joining UW, she has mentored 3 postdocs, 9 graduate students and 6 undergraduates, and has published 16 papers in the field of soil microbial ecology together with her lab group and other collaborators. She has secured several grants to support her research; most notably she is a co-PI on the NSF EPSCoR Track-1 Microbial Ecology Collaborative. She is a dedicated teacher and has continued the development of her teaching skills through participation in programs such as LAMP. She serves on various UW committees and is the Faculty Director of the Ecology & Biogeochemistry Core Lab.

Department of Atmospheric Science

French, Jeffrey

Associate Professor

Jeffrey French (Ph.D.) was appointed to the Atmospheric Science Department in Spring 2015. Dr. French's research focuses on gaining a better understanding of microphysical processes that occur in clouds leading to the production of precipitation. Dr. French uses in situ observations from aircraft to characterize thermodynamic, dynamic, and microphysical properties of clouds. These observations provide the basis for describing which processes may be important under a given set of conditions. Critical to this line of research is the ability to make accurate and well-characterized measurements from aircraft in clouds. To that end, an emphasis is placed on instrument calibration and characterization.

Lebo, Zachary Associate Professor

Zachary Lebo (Ph.D.) joined the Department of Atmospheric Science in the Fall of 2015. His research interests can be broadly categorized as follows: 1) improving our understanding of fundamental cloud microphysics, 2) examining microphysical-dynamical interactions in both stratiform and convective clouds, 3) mesoscale dynamics, and 4) improving and formulating parameterizations for cloud microphysics models. Dr. Lebo's research focuses on the application of numerical models of various scales and complexity, and he has developed several cloud models that are applied in his research. Moreover, he has

also advanced our understanding of the aerosol-cloud-precipitation system in the context of deep convective clouds and suggested new pathways by which cloud microphysical characteristics may change under different aerosol conditions.

Department of Mechanical Engineering

Aidhy, Dilpuneet

Associate Professor

Dilpuneet Aidhy (Ph.D.) joined Mechanical Engineering in the Fall of 2015. His area of expertise are on computational materials science, molecular dynamics simulations, density functional theory. He is also interested in microstructure, grain boundaries, point defects and interfaces. He works closely on Ion transport, radiation effects in solids, interface chemistry, materials-by design, fuel cells, nuclear reactors, and hydrogen storage and fast-ion conductors.

Her primary field of research involves interfacial science and thermodynamics as applied to production and flow in porous media with applications to oil and gas recovery, geological storage of greenhouse gases, and remediation of contaminated aquifers. She is particularly interested in the intricate interplay between fluid-fluid and fluid-rock interactions and their impact on phase behavior and transport. The study of these interactions within a multi-scale framework has been a strategy that she has adopted since starting at UW. In this framework, microscale behaviors provide valuable insights into the thermodynamic forms, conservation equations, and flow properties at the macroscale. This is particularly important for unconventional resources where flow controls are to date an open field of research.
