AGENDA ITEM TITLE: JAC Budget Hearing Update – Seidel/Smith

UW President Ed Seidel provided the Board a summary of the university's testimony before the Joint Appropriations Committee (JAC) during its budget hearing on Friday, December 9, 2022. President Seidel stated the university testimony centered around budgetary impact to people and programs. President Seidel discussed Governor Gordon's recommendation related to state employee salaries, and testimony about inflationary pressures, and necessary upgrades to security in older campus buildings, as well as standing items identified as Board priority. President Seidel reported he felt the members of JAC were supportive of the university's budget requests. Vice President for Government Affairs and Community Engagement Mike Smith provided further report on the JAC discussion regarding the university's capital construction requests, stating the committee requested a clear understanding of past appropriations for individual projects. Provost and Executive Vice President for Academic Affairs Kevin Carman discussed the committee's request for information related to the BSL3 veterinary laboratory and market compensation for pathologists.
