MARK TAYLOR Upon the motion of Mr. Burwell, \$500.00 was appropriated to the Bureau of Educational Research and Service in the College of Education provided funds received by the Bureau would be deposited in the general fund of the University. This motion was seconded by Dr. Cunningham and carried.

Upon the motion of Mr. Sullivan, the appropriation for travel for the Department of Secondary Education (Distributive Education) was increased from \$300.00 to \$600.00, 50% of which will be reimbursed to the University by the State Board for Vocational Education.

Upon the motion of Mr. Watenpaugh, the sum of \$6,000 was appropriated to the Torrington Farm for the purchase of cattle and feed for an experimental feeding project, and \$2,500 was appropriated to the Afton Farm, both from the State Farms sales fund. It is expected that sales from these farms will make these projects self-liquidating. This motion was seconded by Mr. Burwell and carried.

Upon the motion of Mr. Watenpaugh, \$165.00 was appropriated from the unbudgeted balance of the Powell Farm contingent for the payment of a premium on an insurance policy covering the new laboratory and office building now being erected at that station. This motion was seconded by Mr. Burwell and carried.

The Board then approved the cooperative arrangement for furnishing correspondence courses to Wyoming Girls' School at Sheridan as appearing in the President's report with fee charges recommended by Dr. MacNeel of \$8.00 to \$10.00 for high school courses and \$2.00 per credit hour for college courses.

Upon the motion of Mr. Burwell, the Board approved the Memorandum of Understanding between the Board of Trustees and the State Board of Charities and Reform covering operation of the experimental and research program in agriculture on one hundred acres belonging to the Wyoming

MEMORANDUM OF UNDERSTANDING

between

BOARD OF TRUSTEES OF THE UNIVERSITY OF WYOMING, LARAMIE, WYOMING, AND THE WYOMING BOARD OF CHARITIES AND REFORM, CHEYENNE, WYOMING.

This memorandum of understanding between the BOARD OF TRUSTEES OF THE UNIVERSITY OF WYOMING, Hereafter known as the party of the first part, and the WYOMING BOARD OF CHARITIES AND REFORM, hereafter known as the party of the second part, records a mutual agreement as follows:

- 1. That the parties to this agreement propose to set up and undertake an experimental and research program in agriculture on a tract of irrigated land, containing about 100 acres, and belonging to the Wyoming Industrial Institute, near Worland, Wyoming, as authorized by Senate File Number 54, Wyoming State Legislature, 1947.
- 2. That this agricultural experimental and research program shall deal with problems pertaining to the production of agricultural crops, including varietal tests, rotations, alkalinity, irrigation, soils, fertilizers, weed control, livestock pasturing, dry lot feeding of livestock and any other tests or experiment that may contribute to the improvement of agriculture and livestock production in the State of Wyoming.
- 3. That the tract of land used for this experimental and research work shall be in one body and that its location shall be mutually agreeable to both parties to this memorandum.
- 4. That this tract of land shall be used by the party of the first part free from hindrance or interference by the party of the second part for such tests and experimental trials with crops, livestock, poultry, irrigation practices, fertilizers, alkalinity, livestock pasturing, dry lot feeding of livestock, and all other problems related to agriculture, as the party of the first part may choose.
- 5. That the party of the first part may fence at its discretion said tract of 100 acres with a cattle tight fence.
- 6. That the party of the first part will select and pay the salary of a well trained man who is a graduate of an accredited State Agricultural College, to serve as superintendent of all of the experimental and research work.
- 7. That the party of the first part may select from the boys of the Wyoming Industrial Institute with the approval of the party of the second part, a sufficient number to perform all manual labor on the experimental tract; that these boys shall continue through at least one crop season so as to become acquainted with experimental procedure and technique; provided, however, that no boy shall be used for such labor beyond the expiration of his committal period. That the superintendent of the experimental work or his men will be responsible for the boys checked out to him from the corridor until they are checked back in after the days work is completed.
- 8. That the superintendent of experimental work will employ all reasonable means to teach the science of agricultural practices to all boys

detailed to work in the experimental crop fields or with the livestock feeding tests, to the end that such boys upon completing their time at the Wyoming Industrial Institute may be prepared by actual training to assume responsibility as experimental farm technicians or superintendents or as skilled workers for commercial enterprises in agriculture.

- 9. That the superintendent of experimental and research work will, if requested by the superintendent of the Wyoming Industrial Institute, act in an advisory capacity in planning the general agricultural program of the Wyoming Industrial Institute.
- 10. That the party of the first part may use implements, tools, power and other equipment located at the Wyoming Industrial Institute in the prosecution of the experimental and research work when not in use at the Industrial Institute.
- ll. That all funds for the operation of this experimental and research program as provided by the 1947 Wyoming State Legislature shall be administered by the party of the first part.
- 12. That the party of the second part will, if available, provide modern housing accommodations for the superintendent and his family.
- 13. That all crop residues above seed requirements for the following year and amounts for exchange with other experimental institutions and agencies and small amounts of seed to be used by farmers for demonstrations and testing shall belong to the party of the second part.
- lh. That the party of the first part and the party of the second part may jointly agree between themselves on a plan and the providing of facilities for experimental feeding tests with livestock, including cattle, sheep and swine.
- 15. That the party of the first part shall, at the conclusion of each season's work, prepare a full and complete report of the same and deliver said report to the party of the second part; and in State Legislature years, copies of the report shall be delivered within five days after the convening of that body, to the President of the Senate and the Speaker of the House.
- 16. That all questions pertaining to any phase of the experimental work which cannot be amicably settled by the superintendent of the Wyoming Industrial Institute and the superintendent of the experimental work shall be considered and disposed of by one representative of the party of the first part and one representative of the party of the second part, sitting as a joint committee.
- 17. That the party of the first part may publish results of the experimental work from time to time and shall give, in all such publications, full credit to the party of the second part for its contribution to the work.
- 18. That an advisory committee consisting og five to seven persons living in the Big Horn Basin and who are directly interested in irrigated agriculture and livestock production may be selected by the parties to this memorandum, acting jointly, to serve in an advisory capacity on the experimental and research work, when called upon by either party to this

Industrial Institution near Worland with the understanding that the income from the sale of experimental animals go into University sales fund for the station. This motion was seconded by Mr. Watenpaugh and carried.

Upon the motion of Mr. Watenpaugh, the Board declared that the Trustees were in agreement with the policy regarding the relationship between Land-Grant Colleges and the Bureau of Reclamation as appearing in the President's report. This motion was seconded by Mr. Del Monte and carried.

At 2:00 P.M. bids covering alterations to Old Main building were received and publicly opened and read as follows:

Spiegelberg Lumber and Building Co. \$240,655 J. P. Steele, Contractor. \$210,870

After discussion Mr. McCraken moved that all bids be rejected, that the architects be instructed to revise plans and specifications in order to provide for elimination of such features as must necessarily be abandoned in order to keep the cost of the project within the appropriation available, and that new bids be called for on this basis. This motion was seconded by Mr. Del Monte and carried.

The Board then fixed the date for the next meeting to be January 24, 1948, at which time bids will be received for the construction of the new men's dormitory and alterations to Old Main building.

The Trustees also declared that they wished to receive bids for the addition to Knight Hall, and for the new Education building on February 28, and for the construction of the new Agricultural building in May.

It was then moved by Mr. McCraken, seconded by Mr. Sullivan and carried, that the name of Science Hall be changed to Geology Hall.

Mr. Burwell then moved that President Humphrey be authorized to attend a conference conducted by the Mountain States University Press in Denver on December 6 with authority to act on matters affecting this

Upon the motion of Mr. Sullivan, Dr. J. R. MacNeel was granted a sabbatical leave of absence from January 18 to May 18 at 40% of his regular salary. This motion was seconded by Mr. McCraken and carried.

Mr. McCraken then moved that Ira Moore Stevens be appointed Instructor and Research Assistant in Agricultural Economics with the Hope-Flannagan investigational work at a salary rate of \$3,204 on a twelve months' basis with one month vacation, effective December 1, 1947. The President then presented, for the information and consideration of the Trustees, the following letter and study prepared by Dr. George E. Hollister, Head of the Department of Elementary Education. The study, which presents a comparison between salaries of University elementary school teachers and teachers in other leading cities in the state, brings out a very serious problem with which we are faced at this time.

July 30, 1947

Meeting

President G. D. Humphrey University of Wyoming Campus

Dear Dr. Humphrey:

You will recall that about six weeks ago I had the opportunity to talk with you regarding the salaries paid to the members of our elementary school staff. At that time I made the statement that if the members of our staff had taken positions in the larger cities of the state at the same time that they came to the University, they would now be receiving several hundred dollars more in salary. You asked me to secure specific data that would prove this point. The accompanying page of tabulated material is in response to that request.

I should like to call your attention to the fact that all of the figures represent those of regular classroom teachers except the figures in parentheses in the Casper column. You realize that all the members of this staff are called upon to teach college courses, carry on research in our field, and are responsible for the actual training of the teachers who enter the school systems of the state. One would therefore expect that their salaries would be larger than those of the classroom teachers. It would seem that the figures in parentheses for the Casper column where \$300 extra is added for principals and supervisors would make a figure more comparable.

I am sure that you are aware of the difficulty we will have in securing and holding adequate members for our elementary school staff under these salary conditions.

I have shown these figures to Dean Schwiering and have talked over this problem with him. I have his approval to transmit this study to you. We have confidence that you will do all you can to help us solve this very urgent problem. College of Education Salaries Record of Minutes of

The President then presented an agreement which has been entered into between the University of Wyoming and the Wyoming Game and Fish Department for the purpose of a cooperative enterprise for research in wild-life preservation and restoration.

MEMORANDUM OF AGREEMENT

This Agreement made and entered into, in duplicate, this 1st day of October, 1947, by and between the University of Wyoming, hereinafter referred to as University, acting by and through its President and the Wyoming Game and Fish Department, hereinafter referred to as Department, acting by and through its Commissioner, and in consideration of the premises and mutual covenants herein contained agree,

WITNESSETH:

The University agrees to join the Department in a cooperative laboratory enterprise for research in wildlife preservation and restoration, and pursuant thereto shall:

- l. Make available to such cooperative program on its campus one room suitable for use and to be used as the laboratory room one room suitable for use and to be used as an office; and one room to be used as either a storage room or as additional office space, or both.
- 2. Furnish and pay all utilities necessary for the proper conduct and use of the premises aforesaid including heat, light and water.
- 3. Make available to the Department the services of one Ralph F. Honess, one of its employees, to direct the laboratory and program, provided that the demands for such services by the Department shall not exceed one-half working day, of each day, of the time of the said Honess.

The Department agrees to join the University in the cooperative laboratory enterprise aforesaid and pursuant thereto shall:

(a) From its funds, and at its own cost, the Department will cause to be done all remodeling and renovating necessary to make suitable for use for the purposes aforesaid to the premises aforesaid; and provided further that no part of said costs shall be chargeable to or paid out of the project known and described as project number 33-R.

- (b) Furnish, and pay for, all necessary laboratory equipment and supplies for purposes herein.
- (c) To pay one-half $(\frac{1}{2})$ of the annual salary of \$4,008.00 now paid to the said Honess by the University, such payment to be made in monthly installments in the sum of \$167.00 each month.
- (d) To employ all personnel necessary for efficient operation of the laboratory aforesaid provided that, if available, preference shall be given to graduate students of the University and provided further that approval of the Department and the Coordinator of Federal Aid in Wildlife Restoration to appointments of such personnel shall be first had and obtained.

It is Further Understood and Agreed that the terms and conditions of this Agreement shall be in full force and effect from the 1st day of October, 1947, to and including the 30th day of September, 1948.

The President reported on the Hudson Dormitory project as follows:

On September 24 the President, the Comptroller, the Assistant to the President, and the Superintendent of Buildings and Grounds, conferred with Mr. Harry W. Morris, Project Engineer, and Mr. J. E. Prisin-Zano, Attorney for the Public Housing Administration of San Francisco. The terms of the contract for the completion of the Hudson Dormitory were agreed upon and are as follows: (1) the

Public Housing Authority will pay the University \$260,000 for the completion of the building; (2) thirty per cent of that amount, or \$78,000, will be sent to the University immediately; (3) the remainder will be paid on the basis of ninety per cent of the work accomplished per month, the Authority retaining ten per cent pending final acceptance of the building. The contract was examined by Mr. Sullivan and Mr. Simpson and signed by the latter.

Meeting

The President received notification that the University should assume custody of the building at 5:00 p.m. on October 3. After this notification had been received, the Comptroller, with the permission of the President, instructed the J. P. Steele Company to proceed with the completion of the dormitory. Accordingly, work has begun on the project, which the contract states is to be completed by the first of March.

The President presented for consideration by the Trustees, the "Agreement for the Provision of Counselor Training between the University Hypement Between of Wyoming and the State Board for Vocational Education" for the fiscal. year July 1, 1947, to June 30, 1948.

> AGREEMENT FOR THE PROVISION OF COUNSELOR TRAINING BETWEEN THE UNIVERSITY OF WYOMING AND THE STATE BOARD FOR VOCATIONAL EDUCATION

(For the fiscal year beginning July 1, 1947, and ending June 30, 1948)

The State Board for Vocational Education has designated the University of Wyoming as the counselor training institution for the State of Wyoming with the understanding that here-in-after named conditions are met. In order that plans for such training may be submitted to the U.S. Office of Education, and that there may be mutual understanding as to the various responsibilities for training, this agreement is entered into by the University of Wyoming and the State

Board for Vocational Education.

It is understood as a basis of this agreement that the Vocational Division of the State Department of Education is ready and willing to reimburse the University for fifty (50%) percent of the salary and expenses as here-in-after set forth for individuals employed as counselor trainers by the University or jointly by the University and the Vocational Division of the State Department of Education, according to the following provisions. These provisions are in conformity with the State Plan for Vocational Education in effect July 1, 1947.

- I. The University of Wyoming will provide counselor training under the following conditions:
 - (1) The resident training course for guidance counselors shall be given at the University of Wyoming.
 - (2) A qualified counselor trainer shall be employed after a cooperative agreement between the University of Wyoming and the State Board for Vocational Education as to his or her qualifications.
 - (3) A curriculum for counselor training will be outlined by the University of Wyoming and the State Department of Education cooperatively. This curriculum will conform to policies and regulations of the State Plans and be approved by the Office of Education, Washington, D. C., and changes made from time to time shall go through the same procedure outlined above.
 - (4) The University of Wyoming will provide suitable rooms and adequate equipment for counselor training.
 - (5) The University of Wyoming and the State Department of Education will make arrangements for adequate supervised practice in individual counseling for prospective guidance counselors. The amount and location of such practice shall be worked out cooperatively by representatives of the two institutions.
 - (6) The University of Wyoming will report to the State Department of Education the qualifications and progress of prospective counselors in training and on such other detail as the State Board may request.
- II. The University of Wyoming will provide in-service counselor training under the following conditions:
 - (1) The University of Wyoming will provide for

summer school courses in guidance training on both under-graduate and graduate level. The courses offered will be selected by the University and the State Department of Education in cooperation from the list of reimbursed courses outlined in the State Plans for Vocational Education.

- (2) In-service training on an itinerant basis will be provided by the University as extension courses given to teachers, counselors, vocational teachers and administrators in Wyoming schools. The courses to be given and the location of the training shall be determined by the University and the State Department in cooperation.
- III. The State Board for Vocational Education will provide aid from Federal funds available for counselor training at the University of Wyoming and in the schools under the following general conditions:
 - (1) Reimbursement will be allowed only for the expense of counselor training work done under plans approved by the University of Wyoming and the State Board for Vocational Education. Reimbursement will not be made unless, in the judgment of the University of Wyoming and the State Board for Vocational Education, there are sufficient students in a class to warrant the training.
 - (2) Reimbursement will be given for one-half the regular awarded salary for the qualified counselor trainer employed under the cooperative agreement providing he or she teaches only such professional courses as are listed in the State Plans. If he or she teaches other subjects the salary will be prorated on the basis of the weekly program for counselor training and reimbursement will be given for one-half salary paid for teaching professional courses in counselor training.
 - (3) Reimbursement will be given for one-half of salaries paid for teaching special summer school courses in guidance approved by the University of Wyoming and the State Department of Education.
 - (4) Reimbursement will be given for one-half of the cost of such clerical or stenographic help and for instructional supplies as may be needed to carry on the counselor training program.

- (6) Reimbursement will be allowed for one-half of the cost of the office supplies and printing used for counselor training. The cooperative agreement must be secured on all printing prior to having the work done.
- (7) The following budget for counselor training during the year beginning July 1, 1947 and ending June 30, 1948 is hereby approved:

A discussion was then held on the report of the veterans housing requested from Hall and Meeboer on August 2. Such a report is shown immediately below, indicating the income, expenses, and balances in the various veterans' housing projects. It will be noted that during the ten-month period ending September 30, 1947 a balance of \$5,435.26 has accrued in all veterans' housing projects. It will also be noted, however, that the trailer project is in arrears by almost \$14,000. It is hoped that the deficit rate on the trailers will be reduced during the present school term.

The Trustees will also find included in the report of Hall and Meeboer the number of units in the veterans' housing projects, the fair value rental scale, and the number of units presently vacant. Most students are not required to pay the fair value rent approved by the Federal Public Housing Authority. The adjusted rate actually paid averages about \$26 per month for tenants in the row apartments. Adjusted value rents have not yet been computed for other housing units.

Davis, General Chairman, Wyoming War Memorial:

The work of organizing the Wyoming War Memorial Campaign started on June 18, 1947. The office of the director was established in the basement of the Union Building. On July 11 the State Steering Committee, which consists of G. D. Humphrey, Lester Hunt, F. Elton Davis, C. J. "Doc" Rogers, Everett Copenhaver, Keith Thomson, Tom Nicholas, and V. S. Christensen, was organized.

The County Chairmen, as of August 28, are: Ward Husted, Albany; E. O. Huntington, Big Horn; Eph Johnson, Carbon; Joe Sullivan, Converse; Frank Chittum, Crook; Blair Stouffer, Fremont; Will Lynn, Goshen; Lyman Yonkee, Hot Springs, Bill Holland; Johnson; John Hollingsworth, Laramie; Pat Quealy, Lincoln; Walt Kingham, Natrona; Tom Miller, Niobrara; Milward Simpson, Park; Howard Fish, Platte; Mrs. Mabelle Oviatt, Sheridan; George Schmidt, Sweetwater; Fred Toppan, Teton; Lynn Richards, Uinta; Wally Smith, Weston. A meeting of the County Chairmen was held on July 23 and was attended by about half of the Chairmen.

The second piece of work to be undertaken was the preparation of the brochure, "What others do Wyoming can too."

The work of organizing Albany County was begun on August 1. In Albany County a committee of approximately one hundred sixty individuals was appointed by Ward Husted and his Division Chairmen, Elmer Redburn, Tom Craven, Ed Jackson, A. M. Pence, and John Stevenson. To date Albany County has attained a total subscription of \$125,573.05. The solicitation is not yet complete. There are a number of letters out to firms doing business in Laramie, with main offices in other communities, and the "clean-up" solicitation is yet to be held.

The work of organizing Carbon County was begun on August 2. Solicitation has not yet taken place there. The present schedule calls for solicitation to begin as of November 5.

The organization work in Laramie County was begun on September 2. John Hollingsworth and his Division Chairmen, Robert Black, Jack Mabee, George Redhair and O. D. Stevens, appointed a committee of about one hundred. The solicitation there has just begun and it is anticipated that it will be completed by the 7th of November.

The organization of the student and staff campaign was begun on September 26, under the leadership of Dr. S. H. Knight and Floyd Elmgren. To date the total subscriptions from the staff of the University of Wyoming are \$12,548.50, and the total amount subscribed by the students is \$2,892.50. Neither of these campaigns is complete.

The next area of solicitation is that of the Big Horn Basin. The County Chairmen of Park, Big Horn, Washakie, Hot Springs, and Fremont Counties will attend a meeting which is scheduled to be held at Thermopolis on November 3.

The schedule of other areas and their opening date of organization is as follows: Casper will open on January 5. Rock Springs, Kemmerer, and Jackson County Chairmen are to meet on November 24, and Division Chairmen, on February 17, 18, and 19. Torrington and Douglas Divisions will begin their work on April 12 and 13, and Sheridan and Gillette organization meetings will be held on April 14 and 15. This schedule permits the completion of the solicitation of all portions of the state by June 18, 1948.

The total amount of subscriptions from all sources is \$143,064.05. In addition to the above-mentioned campaigns, this includes a subscription of \$50 from Casper and \$2,000 from Cheyenne. There is good reason to believe
