THE UNIVERSITY OF WYOMING

Minutes of the Trustees
March 20, 1981

A visitation meeting of the Trustees of the University of Wyoming was called to order by President McCue at 9:00 a.m. on March 20, 1981, in the Board Room of Old Main.

ROLL CALL

The following Trustees were in attendance: Brodrick, Coulter, Gillaspie, McCue, Nolan, Quealy, Smith, and ex officio members Jennings, Simons, and Hilderbrand. Trustee members Chapin, Sawyer, Mickelson, Miracle, Thorpe, and ex officio member Governor Herschler were absent. The following individuals were also in attendance: Donald L. Veal, Vice President for Research and Graduate Studies; Elliott G. Hays, Vice President for Finance; William G. Solomon, Special Assistant to the President; Vern Shelton, Assistant to the President for Communications Services; Roberta M. Darnell, Assistant Director of Alumni Relations; John Borrelli, Chairman of the Faculty Senate; Donna Ruffing, Chairman of the Staff Council; and William Jones, Legal Counsel for the Trustees.

APPROVAL OF MINUTES

President McCue asked if there were any corrections or

additions to the minutes of February 21, 1981. There were no corrections and President McCue declared the minutes approved as circulated.

ANNOUNCEMENTS

President Jennings said that he was planning a get-together for former Trustees and present Trustees at Spring commencement time. At that time, Mr. Fordyce will receive recognition for having served as a Trustee member.

Briefly, President Jennings discussed his forthcoming trips to visit alumni in San Diego, Los Angeles, Berkley, Portland, and Seattle. Mr. Miracle will be accompanying Dr. Jennings on these visits. On April 23-24, President Jennings will be visiting alumni in Dallas, Fort Worth, and Denver.

EXECUTIVE SESSION

President McCue announced that the Board would convene in executive session to consider a personnel matter. Further, he asked the Board's legal counsel, Mr. William R. Jones, to remain present.

NEW BUSINESS

President McCue said that at this time, the Board would depart from its usual agenda to accommodate the schedule of the Trustees' Attorney, Mr. Jones. Mr. McCue called for new

business and announced that the Board would consider the formal notice of appeal, dated February 4, 1981, and the letter of February 16, 1981, amplifying the request for appeal of Dr. Donald L. Stinson. Mr. McCue stated that he was of the opinion that this matter had two distinct aspects:

- (a) To determine whether or not the Board should grant a hearing on Dr. Stinson's appeal;
- (b) To determine whether or not Dr. Stinson's change of assignment should be rescinded or confirmed, as required by the Trustees' Regulations.

President McCue said he would entertain a motion concerning a hearing on the appeal.

Mr. Quealy moved that the Board not grant Dr. Stinson a hearing because the Trustees' review of the record disclosed no arbitrary action on behalf of the Dean, the Vice President for Academic Affairs, or the President; and further, the record disclosed that the factual situation supported the administrative action taken. The motion was seconded by Mr. Coulter, and it carried unanimously.

President McCue then stated that he would entertain a motion concerning the official position of the Trustees regarding the change of Dr. Stinson's assignment. Mr. Quealy moved that the Board confirm the action of the administration in changing the assignment of Dr. Stinson, effective November 12, 1980, because such action was justified under the factual situation then existing. The

motion was seconded by Mr. Smith, and it carried unanimously.

Mr. Jones left the meeting.

REPORT OF PERSONNEL
COMMITTEE

Mr. Gillaspie reported that the Personnel Committee had reviewed the recommendations contained in the March 19-20, 1981 Trustees' Report as follows: Appointment, Reappointments, Continuation of Probationary Appointments, Department Head in the College of Arts and Sciences, Acting Department Head in the College of Arts and Sciences, Retirements, Retention over age 65, Leaves of Absence, Changes in Sabbatical Leaves, Change in Assignment in the College of Education, and Employment of Graduate Assistants. The Personnel Committee found the recommendations in order and recommended them for approval without any change. Questions on any item were invited. CHANGE IN ASSIGNMENT--
College of Education

Ray V. Clark, Associate Professor of Adult Education and Instructional Services and Head of the Department of Adult Education and Instructional Services, was reassigned as Associate Professor of Adult Education and Instructional Services only, effective May 17, 1981.

EMPLOYMENT OF GRADUATE
ASSISTANTS

Authorization was granted for the appointment of graduate assistants at a stipend of \$5,175 and full fee scholarships up to the number available for inclusion in the 1981-82 operating budget. This operation was requested prior to the approval of the final operating budget since the latest time for appointment of graduate assistants throughout the country is approximately April 15 each year.

CLARIFICATION ON
ELIGIBILITY FOR
GRADUATE SCHOLARSHIPS

President Jennings reported that in 1942, the following policy regarding Graduate Scholarships was approved by the Trustees.

1. That annually there be made available to each of four graduate students, who as undergraduates held University High School Honor Scholarships, an extension of the privileges of this scholarship for three additional quarters, the assignment of these extensions by the Committee on Graduate Study with the approval of the President.
2. That annually there be made available to graduate students, six graduate scholarships, each carrying the same exemptions from the payment of fees enjoyed by those who receive an extension of the University High School Honor Scholarship, these scholarships to be extended for three consecutive quarters of graduate study and to be assigned by the Committee on Graduate Study with the approval of the President.

Now a question has arisen concerning the eligibility of law students for the above-mentioned Graduate Scholarships. In the past, the Committee on Graduate Study has taken the position that law students are not "graduate students", and are thus not eligible to receive the scholarship aid provided for by the above-stated policy. Clearly, law students do not qualify for State-funded undergraduate scholarships. The question, then, is whether it was the intent of the Trustees to exclude law students from both undergraduate and graduate State-funded scholarships.

Currently, the Law School requires a baccalaureate degree as a prerequisite to admission. Given this requirement, it appears that the University regards law students as post-baccalaureate students for all other intents and purposes. This is further indicated by the fact that the University is currently authorizing the awarding of Graduate Assistantships to law students. In the interests of consistency, then, it would appear that law students should be eligible to receive graduate scholarships.

To clarify this issue, Mr. Nolan moved that law students be declared eligible to participate in the Graduate Scholarship Program, with such action to be effective immediately. The motion was seconded by Mr. Smith, and it carried.

PHYSICAL PLANT AND
EQUIPMENT COMMITTEE

Mr. Nolan reported on the
Physical Plant and Equipment

Committee meeting which was held at 10:10 a.m. on March 19, 1981. In attendance at the committee meeting were the following individuals: Trustees Nolan, Brodrick, Coulter, Gillaspie, Smith, McCue, Quealy, Jennings, Hilderbrand, and Simons; Messrs. Arnold, Hays, Henry, Jones, Shelton, Solomon, and Veal of the University staff; and John Borrelli, Faculty Senate Chairman.

1. Engineering Building Addition. Preliminary discussion was held on the bids received February 25, 1981, for construction of the Engineering Building Addition. A bid tabulation is attached as Enclosure 1.

2. Arena-Auditorium Dedication. Proposed plans for the Arena-Auditorium dedication were presented. When beneficial occupancy is achieved, possibly in late November or early December, 1981, an opening to show the facility will be held. After the building has been acoustically tuned, a dedication ceremony will be planned which will include a popular concert, a basketball game, and a symphony concert.

HONORARY DEGREE
COMMITTEE

President Jennings reported that the committee had met and that the committee had nothing to report.

ATHLETIC COMMITTEE

President Jennings reported to the Trustees on the steps taken immediately after the February 26 BYU game to prevent any recurrence at future basketball games of throwing of debris on the playing court or shouting of obscenities at the visiting team or officials. He said, "Steps were taken immediately to prevent any similar incidents at the February 28 game with Utah. Students took the lead and were largely responsible for correcting the situation. They were very much concerned that they, the students of the University of Wyoming, were being judged by the actions of a few. It should be noted that the improper behavior was not limited to the student section."

Some steps taken prior to the Utah game include: new procedures for crowd control, videotape monitoring of the crowd, increased security, public statements by student leaders and University officials urging restraint and a show of good sportsmanship. President Jennings said, "Our students rose to the occasion. They exhibited good sportsmanship throughout the Utah game and took it upon themselves to monitor and regulate the behavior of others. They left no doubt that they, perhaps more than anyone else, were deeply offended by the actions of the few at the BYU game. The State can be proud of how our students corrected

the situation. It was a good ending to a bad situation."

After Dr. Jennings' report, Chairman Smith stated:

As chairman of the Trustee Athletic Committee, I want to publicly commend the students of the University of Wyoming, President Edward H. Jennings, and Athletic Director Bob Hitch for the positive steps taken following the February 26 basketball game with Brigham Young University.

No one can condone the actions of the people who threw debris on the playing floor or shouted obscenities. They certainly can't be called fans and their conduct was inexcusable. However, even before the game was over, President Jennings, Mr. Hitch, and students of the University were taking steps to prevent any recurrence of the actions. Through their efforts, the situation was turned around in less than 48 hours and good sportsmanship was clearly in evidence throughout our game with Utah on February 28.

Public attention has focused on the actions of the few at the BYU game, but little has been said about the positive steps taken and little credit has been given to our students, to our President, and to our Athletic Director for correcting the situation.

Therefore, while publicly commending students of the University of Wyoming, President Jennings, and Mr. Hitch, I want to add my personal thanks to them for not allowing the unthinking actions of a few to tarnish the fine record of the Cowboy basketball team, the University, and our student body.

BUDGET COMMITTEE Trustee Quealy read the
minutes of the March 19 meeting
of the Budget Committee. The committee recommended
Trustees' approval of the golf course rates, of the
board, room and apartment rental rates, and of the increase
in the advance payment deposit. Further, the committee
expressed concern over the possible federal restrictions on

on funding and the results on students financially. The committee felt that the attention of the Legislature should be directed to student aid.

President Jennings reported that the dormitory and food service operations are self-sustaining. He explained that as inflation and labor costs go up, the University has to raise rates to offset expenses. With the proposed increase, the University rates will still be below those of similar institutions and, when combined with tuition, the University's total charges are below the median for the region. Further, he said that priority must be given to maintain financial accessibility to the University and that efforts will be made during the next legislative session to gain additional student aid and scholarship support for students.

Martell Hildebrand, ASUW President, pointed out that while students recognize the need to raise room and board rates, the impact will still be felt. He said, "With the threat of federal budget cuts in student funding, we are going to have even less to go to school on; so we very much appreciate the attitude of the administration and the Trustees in attempting to direct the attention of the legislature to the need for student financial aid."

After the discussion, President McCue called for consideration of the Budget Committee's recommendations.

REPORT ON THE
LEGISLATIVE SESSION

President Jennings presented
the following report on the

legislative session.

It was a very good session for the University. Although this was not a budget session, legislators in both houses were receptive to our requests for supplemental funding and voted essential appropriations for us. Those votes, I believe, are reflective of the respect held for the University, its academic programs, its faculty and staff, and its students.

Before the special session adjourned, legislators authorized an additional six percent for faculty and staff salary increases; approved major improvements in the State Retirement System; added \$3,155,817 to our operating budget for the coming fiscal year; and voted \$22.4 million for major capital construction projects.

In addition, mileage allowances were increased from 17 to 23 cents per mile for passenger cars and from 23 to 31 cents per mile for recreational vehicles and reimbursable travel expenses were increased from \$45 to \$50 per day in-state and from \$55 to \$60 per day out-of-state.

Capital projects funded are an addition to the College of Engineering Building, \$18,500,000; remodeling at the Family Practice Center in Casper, \$110,000; Fine Arts Building lighting, \$46,000; Hazardous wastes holding facility, \$100,000; Ivinson Building air handling system, \$150,000; Coe Library renovation, \$275,000; unallocated funds, \$50,000; equipment for the College of Agriculture Building, Arena-Auditorium, and Power Plant, \$2,300,000; Powell Extension and Research Center land, \$200,000; State Veterinary Lab planning funds, \$155,000; Red Buttes Research Facility, \$500,000; and State Chemistry Lab planning, \$50,000.

Total capital construction appropriation is from the State General Fund. This means our bonding capacity remains intact with the recent favorable decision from the Wyoming Supreme Court. We were in a position to receive authorization in February to issue bonds to finance construction of virtually all of the remaining projects on our current priority list.

The six percent salary funding is on top of the nine percent already authorized for the fiscal year beginning July 1, 1981. Distribution of the salary funding will be in accordance with formulas being developed in consultation with the Faculty Senate, Staff Council, deans, and directors. It is expected the distribution formulas will involve both across-the-board and merit increases.

Retirement bills:

- Clarify retirement terms;
- Authorize State employees' withdrawal of contributions made on his/her behalf unless presently employed by the State;
- Authorize the Retirement Board to negotiate terms and conditions for cities, towns, and counties to participate in the State system;
- Eliminate the money purchase option for new employees and freeze the contribution rate at 5.57 percent for the purpose of payments under such an option;
- Provide that a retirement benefit be computed on a unisex mortality table rather than on a male mortality table;
- Increase the retirement allowance \$2 per month per year of service if retired prior to July 1, 1975 and \$1 per month per year if retired after July 1, 1975 and before July 1, 1980;
- Increase the employer contribution to 5.68 percent from the present 5.57 percent;
- Authorize the investment of retirement funds in preferred and common stock corporations which meet listed criteria;
- Provide that a person who retires and subsequently becomes reemployed with the State shall have the option of either continuing to receive a retirement allowance and not participating in the retirement system or dropping the retirement allowance and being reinstated as a contributing member of the system;
- Increase the present Retirement Board from nine to eleven members; and
- Increase the permissible expenditure for the State's cost of administering the group health and life insurance programs.

A breakdown of the \$3,155,817 supplemental appropriation to the UW operating budget shows \$490,161 for Instruction and Research, including an amendment putting another \$122,000 into nursing, pharmacy, and social work programs, \$1,314,497 for Maintenance, Operation and Repair of Plant; \$218,195 for General Services; \$895,549 to complete the Higher Education Computer Network; and \$237,415 for malpractice insurance premiums in the College of Human Medicine.

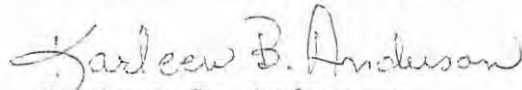
In other action, legislators passed bills exempting the UW Placement Service from provisions of laws relating to employment agencies and established an office of rural and community health in the College of Human Medicine.
