Vice President Chapin called on Chairman Hinckley for a

report of the Academic Issues Committee meeting held on July 27, 1984. Committee members Hinckley, Miracle, Quealy, Sawyer, and <u>ex officio</u> committee member Chapin attended the committee meeting, along with other Trustees and University staff. Committee members Rochelle and Simons were absent. Based on discussions and recommendations from the Academic Issues Committee, the following actions were taken by the full Board. OFF-CAMPUS DEGREE PROGRAMS The Academic Issues Committee

discussed the Off-Campus

Degree Programs. Mr. Sawyer expressed concern that it is the general consensus of the residents around the state that credits from the community colleges are not transferable to the University of Wyoming. Dr. Joyce Scott indicated many

credits are transferable and that the recently revised Wyoming Higher Education Course Transfer Guide will be useful to learn what credits are transferable. Dr. Spitz said that many students who enroll in community colleges do not plan to go on to a baccalaureate program, and then later decide to work toward a higher degree. Mr. Sawyer stated a dedicated effort should be made to bring the community colleges and the University of Wyoming together and the transferability of course credits would be one way in which to accomplish this objective.

To assure equal access to federal financial aid opportunities for the University's off-campus degree students throughout the state, it is necessary to provide the U.S. Department of Education with a comprehensive list of all authorized extended degree programs and the site for which each is approved. To this end, the Academic Issues Committee agreed to recommend to the Trustees reaffirmation of their commitment, as reflected in separate Trustees' actions from 1975 through 1984, to extend its baccalaureate and graduate degree programs to off-campus locations in the State of Wyoming as needs are identified and resources are made available to do so. ATHLETIC COMMITTEE

Vice President Chapin called

on Chairman Smith for a

report from the Athletic Committee meeting held on July 27, 1984. Committee members Smith, McCue, Quealy, Mickelson, Updike, and <u>ex officio</u> members Veal and Chapin attended the committee meeting, along with other Trustees and University staff. Committee member Rochelle was absent. Based on the Athletic Committee's discussions, Mr. Smith gave the following report.

STATUS REPORT ON Dr. Cunningham reported to FOOTBALL TELEVISION PLAN FOR 1984 SEASON the Athletic Committee on recent developments relating to football television for the 1984 season. Following the U.S. Supreme Court's invalidation of the NCAA Television Plan because of anti-trust law violations, the NCAA called a special meeting of its Division I membership on July 10. At that meeting, the Division I schools voted against an alternative NCAA television plan which had been hastily assembled. Following this development,

the University of Wyoming, along with each of the other schools in the Western Athletic Conference, voted to join with the College Football Association in attempting to negotiate a national television broadcast contract for the 1984 season.

Dr. Cunningham stated that the CFA Television Committee had been negotiating for the past two weeks with several national broadcasters and cable networks, and had reached tentative agreements with ABC and ESPN.

The ABC plan provides \$12 million to the CFA for twenty (20) exposures involving member schools, to be televised during a Saturday "time window" of 3:30-7:00 p.m. EST.

The ESPN plan provides for \$9.3 million to the CFA for fifteen (15) exposures involving member schools, to be televised primarily on Saturday evenings.

The WAC would be guaranteed two (2) appearances per season under the ABC plan, and specified appearances per season under the ESPN plan are still under negotiation.

Negotiations for an additional cable television package and possibly a separate conference package are continuing.

The total share of revenues which may be payable to the University is uncertain at this time, but most schools are expected to receive somewhat less revenue from football telecasts during the 1984 season, as the market adjusts in the wake of the Supreme Court's decision.

Dr. Cunningham emphasized that all of the above information relates to the 1984 season only, and that advance planning for football television for the 1985 season and beyond is already underway.

The project budget for furnishing and installation of laboratory equipment is \$361,000, while the project contingency budget has a balance of \$141,724.74. The general contractor is anticipating substantial completion by mid to late August and there will be sufficient funds available in the contingency to budget for the difference in the cost of the furnishings, including alternates.

Based on the Physical Plant and Equipment Committee's recommendation, Mr. Mickelson moved that the Trustees award the contract for the base bid, including all alternates, for a total of \$390,131 for the furnishing and installation of laboratory equipment for the State Veterinary-State Chemistry facilities to the low bidder, Wyoming Interiors. The motion was seconded by Mr. Smith, and it carried.

REMOVAL OF UNIVERSITY HOUSES Mr. Mickelson moved that the University be authorized to

advertise for the removal of houses located at 1208 Bradley, 1211 Lewis, 1205 Lewis, and 808 Fremont; to award contracts to the highest bidder(s); and in the event a bid or bids are not received, or if the bids are unacceptable, to remove by razing or other means said house(s). The motion was seconded by Mr. Gillaspie, and it carried.

LEASE AGREEMENTS WITH CITY OF LARAMIE FOR RECREATIONAL FACILITIES Upon a motion by Mr. Mickelson, seconded by Mr. Sawyer, it

carried to approve the lease agreements with the City of Laramie for Recreational Facilities on University property as described below.

The first agreement provides that the University will lease certain real property to the City of Laramie in exchange for the City's construction and maintenance of semi-permanent spectator facilities and athletic fields thereon. It contains the following salient elements:

- Lease term is from July 1, 1984 to June 30, 2009, with an option to renew to June 30, 2034 upon mutual consent;
- Plans and specifications for the construction on University property of athletic fields and semipermanent spectator facilities must be submitted by the City to the University for approval on or before July 1, 1986;
- Construction of the facilities shall commence by July 1, 1987;
- All costs associated with the construction of the facilities are borne by the City;
- The City has the exclusive responsibility for scheduling the use of the facilities;
- The University is entitled to use the facilities at no cost; and
- The City is required to maintain the premises, and is responsible for all operating costs.

The second agreement provides that the University will lease certain real property to the City of Laramie in exchange for the City's construction of an indoor recreational complex thereon. Previously, on May 15, 1983, the Trustees approved the City of Laramie's preliminary proposal for the use of land for joint recreational development. It contains the following provisions:

 The lease term is from July 1, 1984 to June 30, 2009, with an option to renew to June 30, 2034, at the sole discretion of the City, and an option to renew for a third 25-year term upon the mutual agreement of both parties;

- Plans and specifications for the construction on University property of a sports facility for use as an indoor recreational complex shall be submitted to the University for approval by July 1, 1990;
- Construction of the facility shall commence on or before July 1, 1991;
- All costs associated with the construction of the facility shall be borne by the City;
- 5. The University is entitled to schedule the facility at no cost for University functions, including but not limited to physical education courses and intramurals, and has first priority to schedule twenty percent of the time between 7:00 a.m. and 7:00 p.m., Monday through Friday;
- The City is responsible for maintenance of the facility, and for all operating costs.

REQUEST TO SERVE BEER AT JACOBY GOLF COURSE FOR ONE DAY A request for a one-day permit to serve beer at

the Jacoby Golf Course was discussed. In the Physical Plant Committee meeting, Mr. Gillaspie moved to recommend to the Trustees that a policy be adopted prohibiting the serving of alcoholic beverages at the Jacoby Golf Course, and that no exception to this policy be granted. The motion was seconded by Mr. Sawyer, and was defeated. It was noted that the President had been authorized previously to grant permission for the service and consumption of alcoholic beverages on University property on special occasions on a case by case basis. In accordance with this policy, Trustees directed the President to respond to the request from the Laramie Elks Club for a one-day permit to serve beer at the Jacoby Golf Course.

class enrollment had increased by 51% and is now serving 12,000 people off-campus annually. In 1983-84, 400 students were enrolled in the extended degree program. These students represented 63 communities in 19 different counties.

WYOMING HIGHER EDUCATION COURSE TRANSFER GUIDE Dr. Scott reported that 3,000 copies of the revised Guide

had recently been published and will be available at each of the Community Colleges. They will be available for student purchase in each of the bookstores of the Community Colleges at \$2.50 per copy. Chairman Sawyer requested that the University of Wyoming rededicate itself to furthering a good

Karleen B. Anderson Deputy Secretary MINUTES OF CONFERENCE TELEPHONE MEETING OF THE EXECUTIVE COMMITTEE OF THE TRUSTEES OF THE UNIVERSITY OF WYOMING May 24, 1984

A conference telephone meeting of the Executive Committee of the Trustees of the University of Wyoming was held at 1:30 p.m. on May 24, 1984, with committee members Coulter, McCue, Chapin, Gillaspie, and Mickelson participating. Also participating in the meeting were Donald L. Veal, President; James E. Todd, Vice President for Finance; and William G. Solomon, Special Assistant to the President.

SALARY INCREASE FOR INTERNAL AUDITOR As a routine matter requiring action by the Trustees,

Dr. Veal recommended that Van Jacobson, Internal Auditor, be given a salary increase of \$300 for FY 85. Dr. Veal stated that this recommendation was consistent with the FY 85 salary policy adopted by the Trustees on May 12, 1984, and would increase Mr. Jacobson's annual salary from the current \$33,000 (FY 84) to \$33,300 (FY 85).

Mr. Gillaspie moved that the FY 85 salary increase for the Internal Auditor be approved as recommended. The motion was seconded by Mr. Chapin, and it carried.

TRANSFER FROM TRUSTEES RESERVE ACCOUNT TO TRUSTEES LEGAL FEES ACCOUNT DT. Todd stated that an account designated as Trustees Legal Fees (Account 2430) had been established in the FY 84 budget for the purpose of paying the Trustees' portion (50%) of the costs of litigation on the Arena-Auditorium. Since the anticipated costs of defending that litigation were likely to exceed the amount remaining in the Legal Fees account within the next few months, it was recommended that the Executive Committee authorize the transfer of \$50,000 from the Trustees Reserve account (Account 2498) to the Trustees Legal Fees account.

Mr. Mickelson moved that the transfer of funds be approved as described. The motion was seconded by Mr. McCue, and it carried.

EASEMENT, VETERINARY MEDICINE/STATE CHEMISTRY LAB

Dr. Todd stated that Pacific Power and Light has requested

an easement from Highway 130/230 to the Vet Medicine-State Chemistry Building. The easement would run 250 feet south of Highway 130/230 and then 280 feet east. The contractor is ready for permanent power, and the easement would permit Pacific Power and Light to proceed with the installation of underground electric service.

Upon the recommendation of the administration, Mr. McCue moved that the Executive Committee grant the easement to Pacific Power and Light as described above. The motion was seconded by Mr. Gillaspie, and it carried.

CONFIRMATION OF For purposes of background AUTHORITY TO EXECUTE SERIES A 1984 BOND RESOLUTION information, Mr. Solomon stated that at their May 12, 1984 meeting the Trustees had authorized the President and Secretary of the Board to execute the bond resolution providing for the issuance of the Series A 1984 refunding bonds. Since that legal document was not finalized at the time of that meeting, however, Dean Borthwick, bond counsel for the Trustees, was prepared to give the Trustees only a summary of the document. Since the final resolution had subsequently been mailed to the Trustees, giving them an opportunity to review the details of the complete document, Mr. Borthwick now wished to have a ratification of the earlier authority to execute the resolution.

Mr. Chapin moved that the previous action of the Trustees, authorizing the President and Secretary of the Trustees to execute the above-described bond resolution, be ratified by the Executive Committee. The motion was seconded by Mr. McCue, and it carried.

There being no further business to come before the Executive Committee, the meeting was adjourned.

MINUTES OF CONFERENCE TELEPHONE MEETING OF THE EXECUTIVE COMMITTEE OF THE TRUSTEES OF THE UNIVERSITY OF WYOMING July 6, 1984

A conference telephone meeting of the Executive Committee of the Trustees of the University of Wyoming was held at 11:00 a.m. on July 6, 1984, with Trustees Coulter, Chapin, and Gillaspie participating. Trustees McCue and Mickelson were absent. Also participating in the meeting were Donald L. Veal, President; James E. Todd, Vice President for Finance; William G. Solomon, Special Assistant to the President; Dean W. Borthwick, bond counsel for the University; and Brian Paulson, representing Boettcher and Company, financial underwriters for the Series B 1984 bonds.

AUTHORITY TO OFFER SERIES B 1984 BONDS Dr. Todd reported that, after an analysis of market conditions

and consultation with Boettcher and Company, it appeared that the next ten (10) market days would be favorable for the offering of the Series B 1984 bonds. Accordingly, the administration was seeking authorization from the Executive Committee to offer the bonds during this time-frame.

Following discussion, Mr. Chapin moved that the financial underwriter be authorized to offer the Series B 1984 bonds within the next ten (10) day period, and to authorize Dr. Todd to supervise the offering. The motion was seconded by Mr. Gillaspie, and it carried. SELECTION OF PAYING AGENT AND H REGISTRAR, SERIES B 1984 BONDS

For purposes of background information, Dr. Todd noted

that at their May 12, 1984 meeting the Trustees had authorized the Vice President for Finance to solicit proposals from Wyoming banking institutions to serve as Paying Agent and Registrar for the Series B 1984 bonds, and had further authorized the Executive Committee to select the Paying Agent and Registrar following an evaluation of the proposals submitted. On June 29, 1984, proposals were received from six (6) Wyoming banking institutions.

The call for proposals permitted each banking institution to identify all costs, including annual fees, handling fees, registrar's fees, out-of-pocket expenses and other charges. For purposes of evaluating the fees proposed by each of the banking institutions, Dr. Todd noted that the University had made an assumption that the initial issue would be 500 certificates at an average of \$23,000 per unit. (On the refunding, the average unit was approximately \$23,000).

After a review of the various proposals, Dr. Todd stated that the proposal submitted by Stockmens Bank and Trust, Gillette, appeared to be the lowest submitted, provided the number of certificates did not exceed approximately 1,000. If the number of certificates exceeded 1,000, the proposal submitted by American National Bank, Cheyenne, appeared to be the lowest submitted.

Following discussion, Mr. Chapin moved that Stockmens Bank and Trust of Gillette be selected as the Paying Agent and Registrar for the Series 1984 B bonds. The motion was seconded by Mr. Gillaspie, and it carried.

OLD MAIN REMODEL PROJECT Dr. Todd reported that on July 3, 1984, the following

bids were received on the Old Main Remodel project.

The University's estimate for the project was \$49,000 for the base bid and \$9,000 for the alternate, or \$58,000 total.

Upon a motion by Mr. Gillaspie, seconded by Mr. Coulter, the Executive Committee voted unanimously to award the contract for the "Old Main Remodel" project, including the alternate, to the apparent low bidder, Delta Construction, Inc., in the amount of \$48,544.00.

SPANISH WALK APARTMENTS Dr. Todd reported that

within the last few weeks,

there had been discussions with the Executive Committee of the University of Wyoming Foundation regarding a lease on the Spanish Walk Apartments. Precipitating these discussions was the recent authorization by the Foundation's Board of Directors to dispose of the property through sale. Such an action would, in the administration's opinion, have an adverse impact on housing available to University married students.

The University's interest in the Spanish Walk Apartments is as a result of the following:

- The 332 married student units built in the 1950's are in need of significant rehabilitation, yet the costs of such a project are almost prohibitive. Two years ago, bids were received for weather-proofing the units, and the cost per unit was approximately \$10,000.
- Married student housing remains in high demand. This last year, the waiting list for the University's married student housing remained at approximately 100.

Given the circumstances and the potential transfer of the Spanish Walk Apartments into the private sector, the administration wished to recommend that the possibility of a lease of the Apartments from the Foundation be explored, on the following terms and conditions:

- The lease would be long-term, with options to renew.
- The University would assume responsibility for the operation of the Spanish Walk Apartments and would integrate the apartments into the University's housing operations.
- 3) Lease payments would be based upon the principal and interest owed by the Foundation on the mortgage, plus \$50,000.00 per year, payable monthly on an amortized basis over the term of the lease.
- The University would assume responsibility for all other operating costs.
- 5) The University would assume operational responsibility on August 1, 1984.

Following discussion, Mr. Chapin moved that the Trustees authorize the University to enter into a lease agreement with the University of Wyoming Foundation upon the terms described above. The motion was seconded by Mr. Gillaspie, and it carried.

There being no further business to come before the Executive Committee, the meeting was adjourned.
