## AGENDA

### 1. Call to Order

The meeting was called to order by Trustee President Judy Richards at 6:30 a.m.

### 2. Roll Call was taken by Trustee Rounds

Trustee Warren Lauer was present in the Old Main Boardroom. The following trustees were present by telephone: Charles Brown, Richard Davis, Taylor Haynes, Jim Neiman, David Palmerlee, Judy Richards, Peggy Rounds, Tom Spicer, James Trosper, and Howard Willson. Trustee True was unable to attend. Ex-officio Trustees Philip Dubois and David Willms were in attendance. Ex-officio Trustees Dave Freudenthal and Trent Blankenship were unable to attend the meeting. John Masterson participated via phone for Governor Freudenthal.

### 3. Public Session

Acting presidency - President Richards advised the board that she would entertain a motion to go into executive session in order to discuss the appointment of an acting president. Trustee Haynes so moved; Trustee Davis seconded. The motion carried unanimously. The trustees convened executive session via conference call.
