<u>Classification I</u> – UW Student Organizations – Qualifying groups and activities include:

- UW Student Orgs. meetings, activities, and events where the majority of participants are UW students, and no admission is being charged.
- UW Student Orgs. sponsored events involving non-profit organizations and Wyoming state agencies, where the majority of participants are UW students, staff, and faculty and no admission is being charged.
- Wyoming state agencies will not be charged meeting/facility fees.

Classification II – UW Departments – Qualifying groups and activities include:

- UW administrative, faculty, and staff meetings, activities, and events where the majority of participants are UW students, staff, and faculty and no admission is being charged.
- UW administrative, faculty, and staff sponsored meetings, activities, and events involving non-profit organizations and Wyoming state agencies, where the majority of participants are UW students, staff and faculty and no admission is being charged.

<u>Classification III</u> – External Non-Profit – Qualifying groups and activities include:

- Commercial event, meeting, or program sponsored by a Student Org or the University of Wyoming.
- Non-profit and Wyoming state agencies business, not primarily involving UW students, faculty, or staff. Examples include regional or national student or departmental educational conferences.
- UW Student Orgs. meetings, activities, and events where the majority of participants are not UW students, faculty, or staff and/or admission is charged.
- UW administrative, faculty, and staff sponsored meetings, activities, and events where
 the majority of participants are not UW students, faculty, or staff and/or admission is
 being charged.

Classification IV – External For-Profit – Qualifying groups and activities include:

Commercial and all other off-campus groups.

**Room Setups

Standard – the layout, furniture arrangement, and seating capacity regularly set in the room Special – a rearrangement of existing furniture regularly set in the room

^{**}Sponsored events – A Student Org or UW department agreeing to sponsor an event must be significantly involved in the planning and execution of the event with an external organization with whom there is an obvious organic relationship. The Student Org or UW department contact will be the primary point of contact for the reservation and event details and payment of all related liabilities or costs associated with the event.
