The CAC is working hard. They are working on to support the 5-year plan, with emphasis on DEI and transportation. They have taken on leadership of the Keith A. Miller award, with Chele Porter chairing the committee. Internally, they are working on a formal bylaw review. Specific issues they are addressing:

- Marriage Equality, HR 5408, SSI Savings Penalty Elimination Act
- Transportation: Leo Levengood has taken the lead on establishing the Lions Disability Transportation Services, focused now on Laramie county with goal to expand across the state



Five Year Plan, 2022-2027

Abstract

The Wyoming Institute for Disabilities at the University of Wyoming will improve the education, early intervention, health and wellness, employment, and assistive technology outcomes of individuals with developmental disabilities and their families throughout the five-year project period, 2022-27. Our mission is to assist individuals with developmental and other disabilities and their families by promoting and supporting full community inclusion, community membership, independence, productivity, and social participation.

Project goals include

- 1)** providing interdisciplinary, family curriculum in leadership;
- 2)** educating undergraduate and graduate students in disability studies;
- 3)** providing training to professionals and communities;
- 4)** providing best-practices-based services;
- 5)** conducting basic and applied research, and evaluation and/or public policy analysis;
- 6)** disseminating knowledge-based and accessible information; and **7)** ensuring our business practices support diversity, equity, and inclusion.

Anticipated outcomes related to the goals include increasing:

- 1)** the percentage of URLEND and Disability Studies students from underrepresented populations;
- 2)** the knowledge, attitude, and skills of undergraduate, graduate, and post-graduate students;
- 3)** the number of faculty engaged in the disability studies academic program;
- 4)** the number of collaborations in Wyoming, other states, and globally;
- 5)** knowledge, skills, and use of best practices among professionals;
- 6)** diversity among trainees;
- 7)** telehealth capacity in Wyoming;
- 8)** the number of topics for which technical assistance is provided;
- 9)** the number research proposals, funding awards and dissemination of findings;
- 10)** engagement of our Consumer Advisory Council with program development, implementation, and evaluation;
- 11)** the number of accessible products produced and disseminated; and
- 12)** procurement and dollars awarded to contractors from underserved populations.

Equality State Research Network (ESRN)

The Equality State Research Network (ESRN) is a statewide network committed to engaging in community-based research to improve the overall health of Wyoming residents. The ESRN incorporates community engagement, quality improvement, and scientific inquiry.

Friendships and Dating

WIND's Sexual and Reproductive Health Training for Individuals with Disabilities is designed to decrease rates of pregnancy, sexually transmitted infections (STI), and interpersonal relationship violence and measure changes in relationships and social networks among individuals with disabilities.

Functional Assessment of Standardized Items (FASI)

Eric Moody, Dawn Rudolph

The Wyoming Department of Health (WDH), Division of Healthcare Financing (DHCF), Home and Community Based Services (HCBS) Agency supports over 2,500 participants through three (3) HCBS Waivers. The Centers for Medicare and Medicaid Services (CMS) requires the Agency to conduct initial and annual evaluations of all HCBS waiver participants to determine if individuals require institutional level of care. WIND is exploring the option of using the Functional Assessment of Standardized Items (FASI), identified by WDH as an assessment tool that may meet its primary needs in determining institutional level of care and resource allocation for HCBS waiver participants and NCF Residents.

iCan Connect

Terri Wofford

Wyoming's iCanConnect program provides communications technology free of charge to income eligible people of all ages who have combined vision and hearing loss. This program will distribute communications equipment to qualified individuals and provide equipment installation, training, and support to help recipients make the most of this technology.

Implementing Community Based Telehealth Infrastructure to Expand Healthcare to Vulnerable Populations

Canyon Hardesty

The project supports the establishment of eight (8) community telehealth access sites located at public libraries, UW extension offices, and a local detention center. The equipment purchased for this project will become the property of the community entity (e.g. library, extension office, detention center) where it is installed. Identified sites include three public libraries (Natrona, Park, Sheridan counties), four UW extension offices (Northeast, Southeast, Northwest, Southwest regions) and one detention center (Sweetwater County).

Improving Title X Services for People with Disabilities in Rural Communities

Improving Title X Services for People with Disabilities in Rural Communities is possible with the generous support of INBRE and UNLV. this initiative sets its sights on enhancing Title X services tailored specifically for individuals with disabilities residing in rural communities. With a commitment to inclusivity and accessibility, the project aims to forge pathways towards equitable healthcare access for all, bridging gaps and empowering marginalized populations.

Inventory of Client and Agency Planning (ICAP)

Dawn Rudolph

The ICAP is a standardized measure used by the Wyoming Department of Health to assess adaptive functioning and behavior issues for eligibility in the Developmental Disabilities service system. The Developmental Disabilities Division contracts with WIND to conduct ICAP interviews throughout the state and is responsible for conducting initial, emergency, and continuing eligibility interviews.

Learn the Signs. Act Early -- Ambassador Project

Cari Glantz

The Act Early Ambassador project is designed to develop a network of state-level experts to improve early identification practices. Act Early Ambassadors serve as state liaisons to the "Learn the Signs. Act Early" initiative and work as community champions with programs that serve young children and their parents, such as Head Start and Early Head Start, WIC, home visiting, and others, and health care and childcare professionals to improve early identification of developmental delay and collaborate with state agencies and campaign partners to improve policy and programs for early identification.
